Jennings-TaxSpeaker Preparations, Compilations & Review Seminar Description

Updated through and including SSARS 24, this course and manual is written and taught by actual practitioners. With dozens of example report letters, engeagement letters, client letters and unofficial checklists, this course has been described by attendees as the most useful accounting course they have ever attended.
